DECISION (ON THE PAPERS)

This is an application by Hawarden Golf Club for renewal of an Club Licence in respect of premises situated at Horsley Down Road, Hawarden, known as "Hawarden Golf Club".

The applicant also seeks a variation of hours and extension to the outdoor licensed area. The trading hours for the club bar were discussed at the time of the last renewal application.

The hours of the previous licence were changed to a maximum of forty hours with the bar opening for less hours per week. This enabled the club to meet the Class 3 club criteria.

The club is now seeking to amend the trading hours to provide flexibility for the hosting of tournaments and club related events which may be held on differing days of the week. The bar hours now sought are:

 Monday
 12.00 noon – 7.00pm

 Tuesday
 12.00 noon – 7.00pm

 Wednesday
 12.00 noon – 10.00pm

 Thursday
 12.00 noon – 10.00pm

 Friday
 12.00 noon – 10.00pm

Saturday 12.00 noon – 12.00 midnight

Sunday 11.00am – 10.00pm

This is a total of 67 hours per week. The club has assured the Inspector, the bar opening hours will not exceed 40 per week, therefore it will continue to meet the Class 3 Club criteria.

The Club Captain, Hugh Murchison, advised by email 'We will be recording the duty manager that is on each time the bar is opened and the number of hours that we operate. We will not be going over 40 hours per week.'

The club is reminded that the extension of hours allows for the bar to be open only in association with club based activities, e.g. tournaments, club days, men's/ladies golf, meetings, prizegivings, etc. Other events may require special licences, when the club operates the bar, for functions attended by the public i.e. non-club members.

A plan of the clubrooms has been provided which details the licensed areas, which will be 'undesignated'. An amended plan of the licensed areas has been provided which includes additional outdoor areas.

The licensed areas include:

- The lounge and office, and
- The paved and grassed areas at the front (north) and east side of the clubrooms.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence until 09 August 2021, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.
