

# Notice of Decision



Decision No. 57/OFF/339/2016

**DECISION (ON THE PAPERS)**

This is an application by Terrace Edge Limited for renewal of an Off-Licence in respect of premises situated at 328 Georges Road, Amberley, Hurunui District, known as "Terrace Edge Vineyard and Olive Grove".

The applicant also seeks a variation to the licensed hours.

The current licensed hours are Monday to Sunday 10.00am to 5.00pm. The application requested the hours from 10.00am to 11.00pm. This was queried with the applicant at the time of lodging due to the variation. There was some confusion from the applicant and the application was changed back to the original hours.

During later discussions between the applicant and Licensing Inspector, it became apparent that the applicant had intended to apply for extended licensing hours to avoid the need for special licenses if she were to hold evening events. The premises also hold an On licence until 12.00 midnight.

The new licensed hours are: **Sunday to Monday from 10.00am to 10.00pm.**  
The licensed area is the tasting room and will be undesignated.

A check of the website was made and the site is considered compliant with the information requirements of the Sale and Supply of Alcohol Act 2012 and the regulations.

The appropriate age declaration are displayed. The licence information is displayed at the bottom of the first webpage and repeated on the shopping cart page. Links are provided to both a copy of the licence and the renewal notice (this is not required to be displayed).

Details of the renewed licence are to be updated on the website within 2 working days of the receipt of the renewed licence. This information is:

- The new licence number, and
- The expiry date of the licence, and
- The copy of the renewed licence is to displayed in the link to the licence.

The application was duly advertised and no objection or notice of desire to be heard has been received.

In their reports, the Police, Medical Officer of Health, and District Licensing Inspector have raised no matters in opposition to this application.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act. We renew the licence until 26 March 2022, that being the anniversary date of the licence and three years from the most recent date of expiry.

Due to a practice direction from the Alcohol Regulatory and Licensing Authority we authorise the issue of a replacement licence with a new number and notice of renewal.
