

### **Hurunui District Council – Dog Control Policy & Practices Annual Report**

The Hurunui District Council, as a territorial authority, is required to manage and enforce the rules in the Dog Control Act 1996. Section 10A of the Act requires the Council to report annually on its Dog Control Policy and practices. This report fulfils this statutory requirement for the dog registration year 1 July 2023 to 30 June 2024.

#### **Dog Control Policy**

Council is required to adopt a policy by Section 10 the Dog Control Act 1996.

Hurunui District Council adopted its current policy in September 2018. The objectives of the Policy are to:

- Ensure the owners of dogs comply with their obligations under the Act and that dogs in the district are well cared for;
- Prevent any potential danger caused by dogs to the public, wildlife and natural habitats;
- Minimise the risk of distress and nuisance caused by dogs to the public, wildlife and natural habitats;
- Actively promote the responsible ownership of dogs;
- Provide for the reasonable exercise and recreational needs of dogs and their owners; and
- Provide flexibility to Council Officers to deviate from the policy where unforeseen circumstances justify doing so.

#### **Fees**

Hurunui District Council's Dog Control Fees were for the 2023/2024 financial year are set out below:

#### Fees are used for:

- Dog control activities including law enforcement, patrols and complaint investigation.
- Signs and promotion of the Council's animal bylaw and dog policy.
- Providing pound facilities.
- Running the dog registration programme this includes forms, printing, tags, maintaining the national dog database and related promotional material.

In the 2023/2024 financial year the Hurunui District Council's Income from Dog Control Fees was as follows:

## **Dog Control Officers**

Hurunui District Council employs one full time Animal Management Officer who is responsible for dog control duties. Council's after-hours dog control services are contracted to two contractors, through three area-specific contracts:

- Contract area Northwest: north of the Hurunui River and west of the Lowry Range,
- Contract area Northeast: north of the Hurunui River and west of the Lowry Range
- Contract area South: the area south of the Hurunui River.
